

# Blueberry.

## A. GENERAL

1. The promotion is offered by Blueberry Markets (V) Ltd ("Blueberry Markets"). **Blueberry Markets** is a company providing trading in financial and commodity-based derivative instruments and other securities and which is authorised and regulated by the Vanuatu Financial Services Commission (Company number: 700697) holding License Classes A, B and C under the Financial Dealers Licensing Act. This promotion is exclusive to selected clients. Selected Clients are those who meet the additional Criteria listed below. A Selected Client ("**Referrer**") shall mean a client who has referred new clients to Blueberry ("**Referee**").
2. The promotion shall commence on **18 February 2025** and is available until **31 March 2025 (Promotion Period)**. Any claims or requests made before the Promotion Period will not be eligible for participation unless specifically approved by Blueberry Markets.

This promotion runs in addition to the ongoing standard Refer a Friend program, providing extra rewards for both the Referrer and the Referee during the Promotion Period. Successful referrers are eligible for the standard program rewards as well as cash bonus of this promotion, subject to terms and conditions.

## B. CRITERIA

3. For a **Referrer** to be eligible, they must:
  - a. currently hold a Blueberry Markets live trading account
  - b. be actively trading
  - c. successfully **refer 3 new clients (Referees)** before the end of the Promo period to be eligible for the cash bonus.
4. For a **Referee** to be eligible, they must:
  - a. not have an existing account with Blueberry Markets.
  - b. open an account with Blueberry Markets using the **Referrer's** unique link.
  - c. must make a minimum deposit based on the base currency of the account on or before the end of the Promotion Period, as expressed below (Minimum Deposit):

- d. must trade a minimum of two (2) standard lots over a minimum of twenty (20) trades of any product (FX, Indices, Commodities, Metals, Shared CFDs) where the average trade time is at least thirty (30) minutes. Trades that do not meet this duration, indicative of scalping, will not be counted towards the fulfilment of this requirement. These criteria must be fulfilled within fourteen (14) calendar days.
  - e. must not withdraw more than fifty percent (50%) of their initial deposit within forty-five (45) days from their first deposit.
5. **Important Notice:** This promotion is **NOT** available to Introducing Brokers, Affiliates, and residents of Australia.

## C. CONDITIONS

- 6. The **Referrer** shall receive a **\$200 Cash Bonus**, to be added to their Account base currency when they successfully refer 3 clients (Referees) before the end of the promo period.
- 7. The **Referee** shall receive a **\$100 Cash Bonus**, to be added to their Account base currency when they successfully meet the deposit and trade requirements listed in **Clause B.4.D**
- 8. For both **the Referrer** and **the Referee** to be eligible for the rewards, the **Referees** must register and trade by no later than 31 March 2025.
- 9. Cash bonuses will be transferred to valid trading accounts of successful referrers and referees after the end of the campaign period.
